Complainant, through counsel, unto this Honorable Office, most respectfully submits the Judicial Affidavit of Complainant LEA S. PATRICK, to wit:

**INTRODUCTORY STATEMENT**

On April 7, 2022, in the City of Mandaue City, Cebu, Philippines, the following questions were propounded in English by Atty. Bregette U. Magdoza-Marcojos to the witness, Lea S. Patrick. English is a language which both the witness and counsel fully understand. The witness is fully informed by Atty. Bregette U. Magdoza-Marcojos that she is under oath and that she may face criminal liability for perjury for any false testimony that may be given by her.

The testimony of the witness is offered to prove the material averments in the Complaint for the criminal case of cyberthreat against Zamary Syed Shah specifically to prove that the Defendant Zamary Syed Shah made threats of rape and physical injuries against witness Lea S. Patrick through email.

I, Lea S. Patrick, Filipino, of legal age, Microsoft Tech, married to Gregory Lee Patrick, and residing at Marigondon, Lapu-lapu City, Cebu, after having been duly sworn to under oath, hereby depose and say by way of answer to the following questions:

1. Question: What is your name?  
 Answer: My name is Lea S. Patrick..

2. Question: Are you the witness in this case?  
 Answer: Yes, I am the witness and the private complainant in this case.

Answer: Yes, I am the witness and the private complainant in this case.

3. Question: What is your interest in this case?  
Answer: I am filing a criminal case against Zamarly Syed Shah for cyber threats.
4. Question: What do you know about the Defendant Zamarly Syed Shah?  
Answer: Defendant Zamarly Syed Shah, a Pakistani National, was our former employee, and his last known address was at No. 3 Cica St., North Town Homes, Talamban, Cebu City.
5. Question: When did you meet the Defendant?  
Answer: I met the Defendant sometime on August 2018 or more than three (3) years ago. At that time, he worked as an intern for my husband's business, "The House of DreamMaker".
6. Question: Do you have any other information on the Defendant?  
Answer: Yes. I have a copy of the Defendant's Identification Details and Passport.
7. Question: If you would be shown the copies of Defendant's Identification Details and Passport, would you be able to identify it?  
Answer: Yes.
8. Question: Showing to you the copies of Defendant's Identification Details and Passport, are these the same documents you just mentioned?  
Answer: Yes.
- Your Honor, may we ask the Honorable Court that the copies of Defendant's Identification Details and Passport be marked as our Exhibit "A" to "A-1".
9. Question: How can you describe the Defendant?  
Answer: I remembered the Defendant to be a quiet type of person.
10. Question: What is the name of your husband?  
Answer: My husband's name is Gregory Lee Patrick.
11. Question: Do you have proof of your marriage with Gregory Lee Patrick?  
Answer: Yes. I have a marriage certificate.
12. Question: If you would be shown this marriage certificate, will you be able to identify it?  
Answer: Yes.

13. Question: Showing you a copy of a marriage certificate dated November 28, 2021, is this the same marriage certificate you just mentioned?

Answer: Yes.

Your Honor, may we ask the Honorable Court that the copy of the marriage certificate be marked as our Exhibit "B".

14. Question: What happened in this case?

Answer: Around March 25, 2022, while I was at home reading my husband's emails, I chanced upon several emails sent by the Defendant.

15. Question: What email address did the Defendant use?

Answer: zamar\_y\_shah@hotmail.com

16. Question: How many emails were sent?

Answer: There were around dozens of emails sent by the Defendant to my husband.

17. Question: What did these emails contain?

Answer: There were quite a few unsettling and scary remarks made by the Defendant. The Defendant said the following through email:

(March 15, 2022 5:14 PM)

**"x x x so let me tell you something very straight, I WILL RAPE YOUR WIFE x x x"**

(March 15, 2022 11:34 PM)

**"x x x I WILL RAPE YOUR LEAH GREGORY < I WILL DUMP HER IN SEVERAGE"**

**"I WILL DUMP HER IN THE SEVERAGE WHEN YOU ARE DEAD!!! REMEMBER < IF I TAKE THIS LOSS < I WILL RAPE YOU YOUR FAMILY AND YOUR CAREER APART < I WILL RAPE YOUR CHILDREN x x x"**

(March 16, 2022 12:35 AM)

**" x x x I WILL MAKE SURE GREG, I WILL RAPE YOUR WIFE AND CHILDREN AND DUMP THEM IN SEVERAGE FOR WHAT YOU HAVE DONE TO ME, WHAT YOU HAVE DONE ON MY FACE, REPUTATION x x x"**

And then the Defendant made another online threat on April 1, 2022, saying,

(April 1, 2022 2:39 AM)

**"I will rape Leah and then put my shit in her mouth, and then throw her on same underwear one shirt where she came from"**

18. Question: Do you have proof of these email, Ms. Witness?

Answer: Yes. I have copies of the emails.

19. Question: If you would be shown the emails, will you be able to identify it?

Answer: Yes.

20. Question: Showing to you the copies of emails dated March 15, 2022, March 15, 2022 and April 1, 2022, are these the same emails you just mentioned?

Answer: Yes. They are the same ones.

Your Honor, may we ask the Honorable Court that the copies of the emails dated March 15, 2022, March 15, 2022 and April 1, 2022 be marked as our Exhibits "C" to "C-2", respectively.

21. Question: And then what happened?

Answer: I felt afraid and scared for my life. I was crying. I immediately called my husband.

22. Question: What happened next?

Answer: I later found out that my husband knew about the threats for days. And he actually caused the filing of a Request Black List Order and Declaration as Undesirable Alien against the Defendant.

23. Question: Do you have proof of this Request of Black List Order and Declaration as Undesirable Alien against the Defendant?

Answer: Yes. I have a copy of the request addressed to the Bureau of Immigration.

24. Question: If you would be shown a copy of this request, would you be able to identify it?

Answer: Yes.

25. Question: Showing to you a copy of the Request of Black List Order and Declaration as Undesirable Alien dated March 17, 2022 addressed to the Bureau of Immigration, is this the same request you just mentioned?

Answer: Yes.

Your Honor, may we ask the Honorable Court that the Request dated March 17, 2022 addressed to the Bureau of Immigration be marked as our Exhibit "D".

26. Question: What happened next?

Answer: I filed a police report at the PNP Cybercrime Unit at Lahug, Cebu City regarding the cyberthreats of rape and physical injuries made against me.

27. Question: Do you have proof of this Police Report?

Answer: Yes. I have a copy of the Police Report.

28. Question: If you would be shown a copy of this Police Report, would you be able to identify it?

Answer: Yes.

29. Question: Showing to you a copy of the Police Report dated April 7, 2022, is this the same report you just mentioned?

Answer: Yes.

Your Honor, may we ask the Honorable Court that the Police Report dated April 7, 2022 be marked as our Exhibit "E".

30. Question: Do you have anything else to say?

Answer: Nothing more.

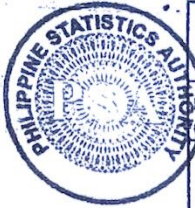
