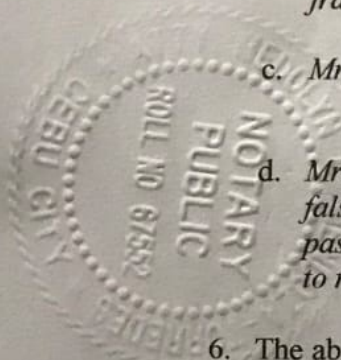

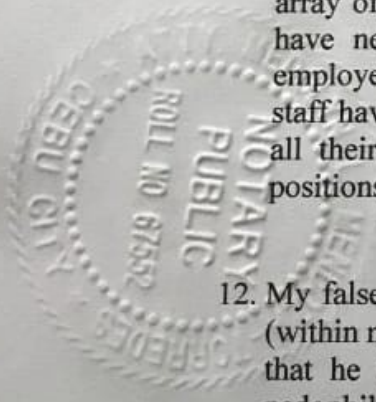
AFFIDAVIT

I, **SHAH SYED ZAMARY**, Pakistani citizen, of legal age, with permanent address at Questta, Pakistan, under oath, hereby depose and state THAT:

1. I am temporarily residing at No. 3 Cica St., North Town Homes, Talamban, Cebu City, Philippines;
2. I am the Marketing Manager of Aventure Corporation, with principal office address at No. 131 Cattleya St., Greenhills Subdivision, Cabanalan, Mandaue City;
3. As Marketing Manager, part of my duties and responsibilities is to develop website, social media, internet marketing, cloud computing, and similar web-based activities for Aventure for which I have full access as an administrator, including passwords, and/or security keys of all its accounts;
4. Gregory Lee Patrick is the President/Chairman of Aventure Corporation;
5. On several occasions, I made certain statements against Aventure Corporation and its President/Chairman, Mr. Gregory Lee Patrick, to the effect that;
 - a. *Aventure Corporation is scam and is not legally documented to do business in the Philippines;*
 - b. *Aventure President/Chairman Mr. Gregory Lee Patrick has committed fraud and is running an illegal corporation;*
 - c. *Mr. Gregory Lee Patrick is a pedophile;*
 - d. *Mr. Patrick brought me here from Lahore, Pakistan two years ago under false pretences, promised me 10% of the company, has withheld my passport, "treated me like a slave" and is not paying me nor allowing me to return to Pakistan.*
6. The above statements/insinuations are pure lies, not true and fabricated out of being vindictive, having had my employment terminated with prejudice. These statements were invented to draw sympathy to my unhappiness, arose out of my subsequent severe alcoholism, personal frustrations, emotional stress, and psychological pressures from being far away from home and hating my life in the Philippines.
7. I acknowledge that I have a written deal package that was agreed to in July of 2017 that graciously offered me a position much like a "junior partner" under what is essentially a personal services contract to the owner. Under this agreement, I agreed to work a schedule commensurate and parallel to the same hours of its President, assist with all aspects of financial modelling, assist in the raising of capital by organizing all business plan efforts and assist by allowing the president more time to focus on his expanding business which has been in operation for 30 years.



8. Part of my compensation is a room in the Corporate house of the President in North Town Homes, a very wealthy development where I reside in a 5,500 sq. ft. home with six full-time, live-in staff including a top chef who prepares my meals, whereby all of my living expenses have been paid for including a car and driver. I have been compensated over and beyond having all personal living expenses eliminated by receiving a \$1,000 net base salary each month and a 50% bonus if I refrained from creating drama and resorted to communicating with fellow colleagues in a professional manner.
9. In addition to my expense free living package, receive 2% of the President's stock and ownership in all assets that enjoy a liquidity event over the next several years including all business units created during my employment with the company. This ownership was to be vested at 2% per annum for five years for a total of 10%. Additionally, my salary would increase proportionately with the President's, always equal to 25% of his salary.
10. My previous statements that Mr. Patrick has withheld my passport and prevented me from departing back to Pakistan is yet another false statement. I acknowledge Mr. Patrick has *never* possessed much less seen my passport and it is true I have had it in my possession since early September after receiving it back from the company's immigration attorney. Because I have applied for a renewal of my working visa, I acknowledge that Mr. Patrick is in fact NOT preventing my timely departure though I accused him of doing so by innuendo when stating such. I acknowledge that I cannot just leave the Philippines because my "9G Visa" expired is with the Bureau of Immigration Manila for the approval of renewal/extension.
11. I acknowledge that Mr. Patrick has been in business for 30 years, has a vast array of very happy clients, all accomplished in their respective fields and I have never seen him do anything to lose their trust and his top three employees have been with him a combined 24 years. Four of his live-in house staff have been with him a combined 16 years and Mr. Patrick pays 100% of all their medical and dental along with salaries commensurate with their positions.
12. My false statement in which emailed to Mr. Patrick's new partner and CEO (within minutes of my termination) was fabricated to have Mr. Watson believe that he was being scammed by Mr. Patrick and that Mr. Patrick was a pedophile. I categorically attest to that being 100% untrue and simply a statement made to cause doubt and discontent between the company's senior management. I acknowledge that I have previously sent pictures of Mr. Patrick's girlfriend and him in the room working so as to imply that he "snuggles" during work hours and acts unprofessionally in front of others.
13. I deeply regret making the above statements/insinuations against Aventureur and its President/Chairman Mr. Gregory Lee Patrick;
14. From this day forward, I promise to conduct myself properly and cooperate fully in training any person assigned to take over my responsibilities, including the turning over to Mr. Gregory Lee Patrick or any of his representative full authority of all documents and passwords I have in all my capacities and hats worn with Aventureur;



15. I acknowledge the following as true:

a. *Aventure Corporation is duly organized under the Philippine Corporation Law. A lawfully existing corporation compliant with Philippine laws, tax payments and regulations;*

b. *Aventure President/Chairman Mr. Gregory Lee Patrick has never committed fraud and is not operating an illegal corporation.*

c. *Mr. Gregory Lee Patrick has a medical condition wherein his back aches when he sits for more than five (5) minutes. His condition requires him to conduct work in his bedroom office since he cannot sit for a long period due to back pain. I, along with several other employees reports to work either in Mr. Gregory Patrick's bedroom office where each one is provided with a working desk or work in the other office within 5 feet from Mr. Patrick's bedroom office, both with very good working space ambiance.*

d. *Mr. Gregory Patrick welcomed me in his household free boarding and lodging for two (2) years and during my stay I have never witnessed him exploit nor abuse any minor, innocent children or person.*

16. I have read and understood the averments in this affidavit and have voluntarily executed this to attest to the truth of the foregoing facts and circumstances and for whatever legal purposes this may serve.
